AN ORDINANCE AMENDING CHAPTER 2, ARTICLE 2, DIVISION 2 SECTION 2-22 OF THE CITY'S CODE AS IT RELATES TO COMPENSATION AND BENEFITS OF THE MAYOR AND COUNCIL

WHEREAS, The Public Employee Benefits Authority, herein after PEBA, does administer the State Health Plan for Cities and Counties in South Carolina;

WHEREAS, the City Council of the City of Tega Cay did unanimously elect to join the State Health Plan in October of 2017;

WHEREAS, the PEBA Board of Directors voted unanimously to amend the definition of "Employee" for the purposes of eligibility to participate in the state insurance benefits program; and

WHEREAS, this amendment from the PEBA Board of Directors allows Councils of participating Counties and/or Municipalities to exercise a one-time, irrevocable option to include or exclude their councilmembers from the definition of "Employee".

NOW, THEREFORE, BE IT ORDAINED, that the City Council of the City of Tega Cay does hereby adopt this Ordinance in its entirety to amend Chapter 2, Article 2, Division 2 and create section 2-22 paragraph (d).

BE IT FURTHER ORDAINED, pursuant to and in compliance with SC Code § 5-7-170, the Council determines that, effective upon the commencement date of the terms of two or more Councilmembers elected at the next municipal election following the adoption of this ordinance, members of Council shall be entitled to participate in the State Health Insurance Plan on the same terms and conditions as do regular employees of the City of Tega Cay.

Sec. 2-22 (d):

Members of Council shall be entitled to participate in the State Health Insurance Plan on the same terms and conditions as do regular employees of the City of Tega Cay.

FIRST READING: June 17, 2024
SECOND READING: July 8, 2024

Enacted this 8 day of JULY, 2024, by a majority vote of the duly elected City Council of the City of Tega Cay, South Carolina. This Ordinance shall be effective January 5th of 2026.
